## 3. PROFILE OF SKILLS AND COMPETENCES

**General competences:**

- be familiar with various methods of learning, use sources of information well, show functional literacy;
- understand assignments or identify the cores of problems, exert variable solutions, work both independently and within a team;
- formulate views and attitudes verbally and in writing, communicate on elementary level in one foreign language, be motivated to extend own language competences;
- cope with changing socio-economic conditions, be financially literate;
- be aware of the labour market mechanisms, and of the employee-employer relationships, act on career decisions responsibly, understand the significance of lifelong learning;
- use basic mathematics and the basic principles of physics and chemistry when needed in daily situations;
- work with the means of information and communication technologies, exploit adequate sources of information, handle information effectively;
- act in an environmentally-conscious manner and in compliance with strategies for sustainability;
- support values of local, national, European and world cultures, recognize the value of life;
- exert fundamentals of health protection, occupational safety, and fire prevention and safety;
- exert norms and prescriptions in the field.

**Vocational competences:**

- monitor physiological functions and status of patients, record it into the documentation, care for motion;
- carry out a complex hygiene care, prevention of pressure sores;
- distribute food diets to patients and ensure diet keeping, ensure compliance with drinking regime;
- ensure the application of heat and cold;
- carry out rehabilitation nursing, including the prevention of disorders of mobility;
- carry out self-care training to increase self-sufficiency of the patient;
- participate in gaming activities for children;
- participate in the acceptance, control, manipulation and storage of medicine;
- participate in the acceptance, control, manipulation and storage of medical devices and clothes;
- dose remedies with the exception of intravenous and epidural catheters and intramuscular injection in neonates and children under 3 years of age;
- take biological material, carry out the examinations of biological material obtained through non-invasive methods and of capillary blood obtained through semi-quantitative methods (diagnostic strips);
- introduce and maintain oxygen therapy;
- contribute to the treatment of acute and chronic wounds;
- prepare patients for diagnostic or therapeutic procedures, provide nursing care during these procedures, and after them;
- participate in activities connected to the reception, relocation, release and death of patients;
- work with medical documentation.

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE


The graduate is employed in medical facilities both in patient or ambulance type and in nursing home care. He/she works as healthcare worker in social care facilities, esp. in hospitals for long-term patients, in social care centres for persons with disabilities, geriatric care facilities and facilities of hospice and respite care.
